



## Child-Care Prices for 2022 - 2023

Effective June 1, 2022 - May 31, 2023

### Full-Time Weekly Prices:

Full-time is defined as having access to our services on all days that we are open, Monday thru Friday for more than 5 hours per day. **Breakfast, lunch and snacks included.**

A one-time not refundable enrollment fee of \$55 dollars must be paid prior to enrollment (\$45 for the 2<sup>nd</sup> child).

## Part-Time Weekly Prices:

Part-time is defined as having access to our services with a maximum of three days per week, Monday thru Friday from 7:00AM – 6:00PM. These days will be selected by the parents at time of registration, and can be changed with a two weeks notice.

A part-time rate will be offered also for children who will be in care for less than 5 hours a day.

Fees are due by the first day of care of each week. Fees may be paid in cash, check, email money transfer, Debit or Credit. Any fees received later than the first day of the service week are subject to a \$5 a day late charge and any returned checks are subject to a \$30 service charge. If fee payment is more than 3 days late, all service will be suspended until fees are paid in full. Returned check may result in cash only payment policy for future services. Full fees are due regardless of a child's illness, statutory holidays or holiday days off. A receipt for fees paid throughout the year will be provided at the end of each year for tax purposes – monthly receipts are available upon request. Fees are subject to increase with a minimum of two weeks notice.

**If minimum wage requirements are increased, weekly tuition rates may also be increased mid-year.**

## Vacation

After 6 months of full-time, continuous care, we offer 2 weeks of vacation time a year where tuition will be half-price for a child that is absent for a full week. We ask that a minimum of 2 weeks notice is given before vacation days are given. Weeks do not need to be taken back-to-back but must be used as a whole week (not one day here, one day there, ETC). Vacation weeks do not carry over from year to year, and reset December 31st, each year.
